- <C>1. Wire ropes are to be of an anti-rotation type.
- <C>2. At the locations of the crane control position and embarkation area, a notice indicating the safe working load, the maximum slewing radius, maximum wind velocity, maximum wave height, minimum visibility, and other restrictive conditions for personnel transfers is to be provided.

Personel transfer system device for Hose Handling CRANE

- This drawing is approved for additional personnel transfer device of Hose handling crane.
- Appropriate communication devices are to be provided to the operational master, the crane operator, the signalmen, and persons in the basket.
- Wind gauge is to be provided to ensure that the operational master can be informed of the wind velocity.
- Operation Manual is to contain the followings.
 - Items to be checked prior to use of the basket, which contain at least the following:
 - Specifications of the basket such as its own weight, SWL and capacity
 - Maintenance records
 - Certifications issued by an official body or a third-party body
